- 5. Michael Baker International, NY

**WHEREAS,** the Facilities Review Board has reviewed this proposal and unanimously recommends its approval by the Authority Board.

**NOW, THEREFORE, BE IT RESOLVED** that the Authority designates Hazen and Sawyer, Jacobs, Dewberry, AECOM and Michael Baker International as eligible to provide engineering services to the Authority for a period of one year commencing on February 1, 2021 and shall be compensated in an amount to be determined during the solicitation and selection process.

**BE IT FURTHER RESOLVED** that the Executive Director of the Authority shall affix his signature to the contract and that the Secretary of the Authority shall publish a notice in the paper in accordance with the Local Public Contract Law.
