

**RESOLUTION AUTHORIZING THE AWARD OF THE CATCH BASIN
CLEANER TRUCK PROJECT**

WHEREAS, the North Hudson Sewerage Authority (hereinafter "Authority") is a public body, duly formed under the Sewerage Authorities law, constituting Chapter 138 of the Laws of New Jersey of 1946, as amended (Chapter 14A of Title 40 of the New Jersey Statutes Annotated) and possesses the powers set forth therein; and

WHEREAS, the Authority has identified capital projects required throughout its service area that must be performed in order to maximize the performance of its waste water treatment facility, the capacity of its combined sewer system and/or to comply with its New Jersey Pollution Discharge Elimination System (NJPDES) permit; and

WHEREAS, the Authority has determined to undertake the Catch Basin Cleaner Truck Project as described in Appendix A hereto (the "Project"); and

WHEREAS, the Authority publicly advertised such Catch Basin Cleaner Truck Project as required by the New Jersey law; and

WHEREAS, one (1) bid was received being the lowest responsible bid came from Jack Doheny, Inc., Wharton, NJ, in the amount of \$690,000.00 as compared to the Engineer's estimate of \$700,000.00; and

WHEREAS, the Chief Financial Officer has certified that funding is available through the Authority's Capital Improvement Program; and

WHEREAS, the capital budget of the Authority is hereby amended to conform with the provisions of this resolution to the extent of any inconsistency herewith; and

WHEREAS, the Facilities Review Board has reviewed the bid and recommends award of the contract to Jack Doheny, Inc., Wharton, NJ, in the amount of \$690,000.00.


