
WHEREAS, the Facilities Review Board has reviewed the proposal and recommends the approval of the request.

As you have requested, Mott MacDonald has provided the following request for a budget modification as it pertains to the above referenced project.

This request is being split into the following components:

- 1. Separating the Project into Different Contracts and Rebid
- 2. Value Engineering Change Order for West New York Parking Lot

Scope of Work:

Mott MacDonald proposes the following scope of work:

Task 1 - Separating the Project into Two Contracts and Rebid

At the direction of the Authority, Mott MacDonald split the project into two different projects and obtained the appropriate approvals from the State to ensure the separate contracts would be funded. This work includes making two separate sets of bid documents and includes engineering services from the design phase through construction.

Task 2 – West New York Parking Lot Value Engineering

Mott MacDonald worked with the contractor to reduce the construction cost of the West New York Parking Lot. This includes a partial redesign and making modifications to save money while maintaining quality and ensuring the intent of the project is realized.
