**WHEREAS,** the North Hudson Sewerage Authority (hereinafter "Authority") is a public body, duly formed under the Sewerage Authorities law, constituting Chapter 138 of the Laws of New Jersey of 1946, as amended (Chapter 14A of Title 40 of the New Jersey Statutes Annotated) and possesses the powers set forth therein; and

**WHEREAS,** the Authority has awarded a biennial contract for the Miscellaneous Repair to combined sewers of various configurations, lengths, sizes materials and their appurtenances; and

**WHEREAS,** the Authority awarded such a Miscellaneous Repair Contract as required by the New Jersey Contract laws to Cliffside Paving; and

**WHEREAS,** it is the recommendation of the Authority Engineer that Cliffside Paving, be directed to commence the work as detailed in the attached report prepared by OMI (December Project), identified as "Exhibit A", for an amount of money estimated at approximately \$37,375.00; and

**WHEREAS,** the Chief Financial Officer has certified that funding is available through the Authority's Fiscal Year 2022-2023 Operating Budget.


**NOW, THEREFORE, BE IT RESOLVED** that Cliffside Paving be directed to proceed with the work as herein noted.

The Miscellaneous Repair Biennial Contracts: 2022-2024 will be awarded to Cliffside Paving LLC. On March 17, 2022. OMI has prepared a repair project for December 2022. The estimated costs of these repairs are based on unit prices bid by Cliffside Paving LLC.

Attached is the scope of work and estimated construction costs for the Miscellaneous Repair Biennial Contracts: 2022-2024 – December 2022 Project. OMI developed the list based on field inspections and resident concerns, and has estimated quantities and costs for the project.

The proposed December 2022 Project consists of six repairs in Hoboken, one repair in Union City, and eight repairs in West New York. The Construction costs for the fifteen repairs is estimated to be \$37,375.00 and repairs should be completed in four weeks.

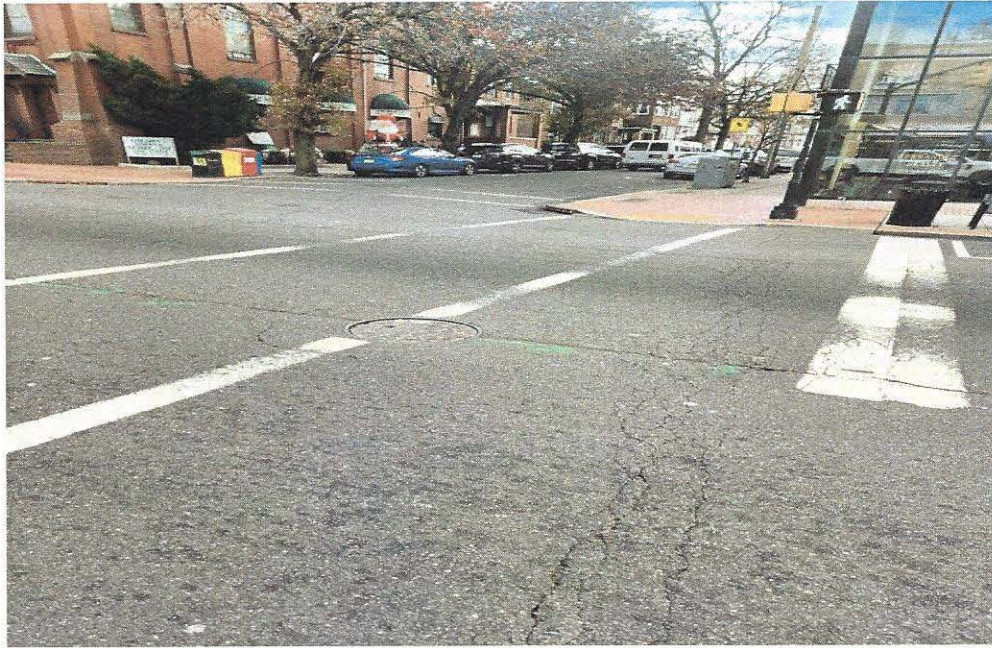
