WHEREAS, the North Hudson Sewerage Authority (hereinafter "Authority") is a public body, duly formed under the Sewerage Authorities law, constituting Chapter 138 of the Laws of New Jersey of 1946, as amended (Chapter 14A of Title 40 of the New Jersey Statutes Annotated) and possesses the powers set forth therein; and

**WHEREAS,** AECOM has been selected under resolution 22-050 to provide engineering services during construction for the South Union City Drainage Study Project; and

WHEREAS, AECOM has submitted a request (Exhibit "A") for additional compensation in the amount of \$42,900.00 related to additional engineering services performed for items related to the South Union City Drainage Study Project; and

**WHEREAS**, the Authority has determined to undertake, and hereby amend the scope of, the South Union City Drainage Study Project as described in Appendix A hereto (the "Project") pursuant to Resolution No. 22-050 adopted on May 19, 2022; and

**WHEREAS**, the Authority has determined that the total estimated cost of the additional compensation will be an amount not to exceed \$42,900.00; and

**WHEREAS,** the Chief Financial Officer has certified that funding is available through the Authority's Capital Improvement Program; and

**WHEREAS,** the capital budget of the Authority is hereby amended to conform with the provisions of this resolution to the extent of any inconsistency herewith; and

WHEREAS, the Facilities Review Board has reviewed the proposal and recommends the approval of the request.

**NOW THEREFORE, BE IT RESOLVED** that the Authority, as recommended by the Facilities Review Board, approves of AECOM provision of additional professional engineering and construction services as outlined in Exhibit "A" and shall be compensated in an amount not to exceed an additional \$42,900.00.

### North Hudson Sewerage Authority South Union City Drainage Study Contract Modification No. 2

April 6, 2023

Dear Mr. Pocci:

The purpose of this letter is to recommend Contract Modification No.2 to the North Hudson Sewerage Authority (NHSA) for the South Union City Drainage Study Project. NHSA entered into an agreement with AECOM Technical Services Inc. on May 19, 2022, to provide professional engineering services as set forth in the Request for Proposals for the South Union City Drainage Study in the amount of \$296,098.31. The NHSA Board approved Contract Modification No. 1, in the amount of \$17,571, by vote on March 16, 2023. Contract Modification No. 1 extended the flow metering period by three months, to March 31, 2023.

The Contract Modification No. 2 consists of additional work as summarized herein:

- Extend the duration of flow metering for meters NHUC-1, 2, 3, 4 and 5, and the rain gauge by four (4) months, until July 31, 2023, and provide analysis of the flow meter data for the additional period.
- Provide contract management and coordination of the flow metering program, including periodic review of interim flow meter data as recorded on ADS's viewing portal, for the extended flow metering period.

The following is a summary of the additional costs:

- Five (5) meters and one (1) rain gauge to remain in place for an additional four
  (4) months amount of \$22,800 for subcontractor, ADS.
- Coordination of the extended flow metering program under Task 2 amount of \$11,600 for AECOM
- Contract management for the extended period of flow metering under Task 5 amount of \$8,500 for AECOM
- Total additional cost of \$42,900

The summation of the two (2) contract modifications represents an 14% increase in the original contract as summarized below:
