

**RESOLUTION AUTHORIZING THE AWARD OF THE
H6/H7 CSO LONG TERM CONTROL PLAN PHASE 2 PROJECT**

WHEREAS, the North Hudson Sewerage Authority (hereinafter "Authority") is a public body, duly formed under the Sewerage Authorities law, constituting Chapter 138 of the Laws of New Jersey of 1946, as amended (Chapter 14A of Title 40 of the New Jersey Statutes Annotated) and possesses the powers set forth therein; and

WHEREAS, the H6/H7 CSO Long Term Control Phase 2 Project consists of installing mechanical equipment within the stormwater pump station wetwell previously constructed in Phase 1 and the associated piping and appurtenances, electrical controls and associated appurtenances within the previously constructed Control Building, discharge force main, and gravity stormwater pipe. Project work will also include subsurface investigations for delineation and characterization of soils that will be excavated and properly disposed of and will also include sampling of dewatering waste prior to discharge; and

WHEREAS, pursuant to a solicitation of bids for the H6/H7 CSO Long Term Control Phase 2 Project, five (5) bids were received with the lowest responsible bid from Underground Utilities, Linden, NJ, in the amount of \$16,218,031.50 as compared to the Engineer's Estimate of 14,357,175.00; and

WHEREAS, the Facilities Review Board has reviewed the bids and recommends award of the contract to Underground Utilities, Linden, NJ, in the amount of \$16,218,031.50.



The North Hudson Sewerage Authority (NHTSA) received bids for the subject Contract on February 15, 2023, at 1:00pm. Five (5) responsive bids were received. The bids are as follows:

- Underground Utilities Corp. - \$16,218,031.50
- Montana Construction Corp., Inc. - \$18,746,711.00
- Tomco Construction, Inc. - \$20,975,200.00
- Northeast Remsco Construction, Inc. - \$21,040,399.40
- J. Fletcher Creamer and Son, Inc. - \$21,457,725.00

The Engineer's Estimate for the work was \$14,357,175.00.

We have prepared the attached Bid Tabulation for your use. We find the lowest bid submitted by Underground Utilities Corp., to be fair and reasonable for the work to be performed. Subject to review by the Authority's Legal Counsel, we recommend award of a contract to Underground Utilities Corp., in the amount of **\$16,218,031.50**.
