

**RESOLUTION AUTHORIZING THE AWARD OF THE
PORT IMPERIAL PUMP STATION NO. 3 REHABILITATION PROJECT**

WHEREAS, the North Hudson Sewerage Authority (hereinafter "Authority") is a public body, duly formed under the Sewerage Authorities law, constituting Chapter 138 of the Laws of New Jersey of 1946, as amended (Chapter 14A of Title 40 of the New Jersey Statutes Annotated) and possesses the powers set forth therein; and

WHEREAS, the Port Imperial Pump Station No. 3 Rehabilitation Project consists of cleaning the wet well, removing existing wet well equipment and piping, and installing new pumps, guide rails, and discharge piping. Installation and maintenance of a temporary bypass pumping system to isolate the wet well during construction, as well as excavation and disposal of excavated material; and

WHEREAS, pursuant to a solicitation of bids for the Port Imperial Pump Station No. 3 Rehabilitation Project, four (4) bids were received with the lowest responsible bid from Scafara Contracting, Cedar Knolls, NJ, in the amount of \$524,500.00 as compared to the Engineer's Estimate of \$524,575.00; and

WHEREAS, the Facilities Review Board has reviewed the bids and recommends award of the contract to Scafara Contracting, Cedar Knolls, NJ, in the amount of \$524,500.00.



On Thursday, May 25, 2023, at 11:00 AM, bids were received for the above referenced contract. Four bidders submitted proposals which ranged from \$524,500.00 to \$1,394,311.43.

The apparent low bidder, Scafara Contracting Inc of Cedar Knolls, New Jersey, submitted a bid in the amount of \$524,500.00, which was \$158,090.00 less than the second low bidder submitted by Rapid Pump & Meter Service CO, Inc. bid of \$682,590.00.

As the attached bid summary indicates Scafara Contracting Inc bid is \$75,500.00 lower than our Engineer's Estimate which indicates that the Authority received competitive proposals.

The low bidder, Scafara Contracting Inc is a reputable company that has demonstrated the ability to successfully complete the work on similar projects.

Our office has contacted Scafara Contracting Inc and they have indicated that they are willing to enter into a contract with the Authority to perform the work.

In our opinion, the Authority has received a competitive and responsive bid for the project. Accordingly, we recommend that the Authority award the Contract to Scafara Contracting Inc in the amount of \$524,500.00 subject to review of legal counsel.
