WHEREAS, the North Hudson Sewerage Authority (hereinafter "Authority) is a public body, duly formed under the Sewerage Authorities law, constituting Chapter 138 of the Laws of New Jersey of 1946, as amended (Chapter 14A of Title 40 of the New Jersey Statutes Annotated) and possesses the powers set forth therein; and

WHEREAS, pursuant to the approval granted by virtue of R.23-029, the Authority has contracted with National Water Main Cleaning Company, Kearny, NJ, in the amount of \$1,142,519.50 for the Collection System Improvements - Contract 1 Project; and

WHEREAS, the purpose of this request for a contract modification is to compensate the contractor for additional work performed, as well as provide a time extension for the project. The additional cost is to reimburse the contractor for moratorium fees required to obtain road opening permits in West New York. The change order will also provide a 100 calendar day no cost time extension to the contract. Additional time is required as obtaining permits has delayed work.; and

WHEREAS, the Facilities Review Board has reviewed the proposal and recommends the approval of the requested contract modification.

NOW, THEREFORE, BE IT RESOLVED that the Authority hereby authorizes the execution and implementation of said contract modification # 01 in the amount of \$4,709.46.

CHANGE ORDER RECOMMENDATION - CO No. 1

Dear Mr. Pocci:

Pursuant to our inspections and consequent negotiations with the Contractor, National Water Main Cleaning Company (NWMCC), for the Collection System Improvements Project Contract 1, Kleinfelder is recommending that the North Hudson Sewerage Authority (NHSA) approve Change Order No. 1 in the amount of \$4,709.46 for reimbursement of moratorium fees in West New York and a 100 calendar day time extension in order to complete the remaining work in the project. Detailed descriptions of the Change Order Requests (CORs) are included below:

COR #1 – Time Extension Request

NWMCC is requesting a 100 calendar day non-compensatory time extension due to lengthy delays in receiving permit approvals from Union City and West New York. The Contractor faced delays in receiving approvals from the police department in Union City to perform the cleaning and closed-circuit television (CCTV) work and faced additional delays in securing road opening permits in both Union City and West New York, despite their efforts to try to keep the project moving forward. The cleaning and CCTV work was able to be completed at the beginning of July, and the lining and excavation spot repair work is scheduled to begin in August. COR #1, prepared by NWMCC, is attached to this recommendation for your reference. This is a non-compensatory time extension; therefore, no additional cost is associated with this time extension. The new project completion date as a result of this time extension is September 29, 2023.

COR #2 - Reimbursement for Moratorium Fees Request

NWMCC is requesting reimbursement for moratorium fees associates with road opening permits in West New York. Upon submitting the required road opening permits to West New York for the excavated spot repairs, Underground Utilities (subcontractor) and NWMCC were notified that three (3) locations required additional fees, since the roads were under moratorium and paved within the last five years. NHSA, Kleinfelder and NWMCC requested the additional fees be waived, since the nature of the work is an improvement to West New York; however, no waiver was granted, and West New York is requiring payment of moratorium fees. Since NWMCC and Underground Utilities had no prior knowledge of the roads being under moratorium or these moratorium fees based on the Bid Documents, Kleinfelder is of the opinion that reimbursement for the fees is fair and reasonable. COR #2, prepared by NWMCC, is attached to this recommendation for your reference.
