WHEREAS, the North Hudson Sewerage Authority (hereinafter "Authority") is a public body, duly formed under the Sewerage Authorities law, constituting Chapter 138 of the Laws of New Jersey of 1946, as amended (Chapter 14A of Title 40 of the New Jersey Statutes Annotated) and possesses the powers set forth therein; and

WHEREAS, The 1-year repair contract will provide the Authority with a repair program to perform miscellaneous street paving and restoration throughout the service area. The Contractor will be on call and will perform the work required at the unit prices bid; and

WHEREAS, pursuant to a solicitation of bids for the Miscellaneous Paving and Restoration Repairs Contract 2023-2024, two (2) bids were received with the lowest responsible bid from D&L Paving Contractors, of Nutley, New Jersey, in the amount of \$247,350.00 as compared to the Engineer's Estimate of \$265,000; and

WHEREAS, the Facilities Review Board has reviewed the bids and recommends award of the contract to D&L Paving Contractors, of Nutley, New Jersey, in the amount of \$247,350.00.




Re: Paving and Restoration Repair Project Bid Results

Dear Mr. Conger,

On Tuesday, October 10, 2023, bids were received for the above referenced project. Two (2) bidders submitted proposals: Underground Utilities for \$426,000.00 and D&L Paving for \$247,350.00. The Engineer's estimate for this project was \$265,000.00. After reviewing both competitive and responsive submissions along with the Engineer's summary, the apparent low bidder is D&L Paving with a bid amount of \$247,350.00. The purchasing and technical review is now complete. Proposal may be presented to the Facilities Review Board for Authority Board approval.

Please note that final contract award approval is subject to legal review and bond insurance requirements.
