

**RESOLUTION AUTHORIZING THE AWARD OF A FAIR AND OPEN CONTRACT
FOR ON CALL ENGINEERING SERVICES PURSUANT TO N.J.S.A. 40A:11-3(B)**

WHEREAS, the North Hudson Sewerage Authority (hereinafter "Authority") is a public body, duly formed under the Sewerage Authorities law, constituting Chapter 138 of the Laws of New Jersey of 1946, as amended (Chapter 14A of Title 40 of the New Jersey Statutes Annotated) and possesses the powers set forth therein; and

WHEREAS, the Authority has the need for engineering firms to provide on-call services in planning, surveying, design, information technology, construction contract administration, resident inspection and general technical support for the following major service areas:

1. Wastewater Treatment Facilities
2. Wastewater Collection Systems
3. Pumping Stations
4. Geographic Information Systems (GIS)
5. Energy Systems

for the purpose of evaluating system requirements and preparing various investigations and reports as required by its NJPDES permit.

WHEREAS, the Facilities Review Board has reviewed the proposals received by the Authority on January 10, 2024 and recommends the selection of the following firms:

1. Hazen and Sawyer, Iselin, NJ
2. Jacobs, Morristown, NJ
3. Dewberry, Parsippany, NJ
4. AECOM, New York, NY
5. Kleinfelder, Princeton, NJ
6. Entech Engineering, Iselin, NJ
7. H2M, Parsippany, NJ

WHEREAS, the Facilities Review Board has reviewed this proposal and unanimously recommends its approval by the Authority Board.

NOW, THEREFORE, BE IT RESOLVED that the Authority designates Hazen and Sawyer, Jacobs, Dewberry, AECOM, Kleinfelder and Entech Engineering as eligible to provide engineering services to the Authority for a period of one year commencing on February 1, 2024 and shall be compensated in an amount to be determined during the solicitation and selection process.

BE IT FURTHER RESOLVED that the Executive Director of the Authority shall affix his signature to the contract and that the Secretary of the Authority shall publish a notice in the paper in accordance with the Local Public Contract Law.

BE IT FURTHER RESOLVED that the Authority has awarded this contract for professional services pursuant to N.J.S.A. 40A:11-3(b), . . .contracts for Professional Services pursuant to subparagraph (i) of paragraph (a) subsection (1) of section 5 of P. L. 1971, c.198 (N.J.S.A. 40A:11-5) may be awarded for a period not exceeding twelve (12) consecutive months.”



NOTICE OF RESOLUTION AUTHORIZING THE AWARD OF A FAIR AND OPEN CONTRACT FOR ENGINEERING SERVICES PURSUANT TO N.J.S.A. 40A:11-3(B)

THE NORTH HUDSON SEWERAGE AUTHORITY (the "Authority") has awarded a Fair and Open Contract for On Call Engineering services pursuant to N.J.S.A. 40A:11-3(b), . . .contracts for Professional Services pursuant to subparagraph (i) of paragraph (a) subsection (1) of section 5 of P.L. 1971, c.198 (N.J.S.A. 40A:11-5) may be awarded for a period not exceeding twelve (12) consecutive months. The North Hudson Sewerage Authority has retained Hazen and Sawyer, Jacobs, Dewberry, AECOM, Kleinfelder, Entech Engineering and H2M to provide on-call engineering services in connection with the management and operation of the Authority. The amount charged for these services will be determined in accordance with the Proposals received on January 10, 2024 on file with the Secretary of the Authority. This Contract will be in effect for one year or until such time as either party gives written notice to the other of termination.
