WHEREAS, the North Hudson Sewerage Authority (hereinafter "Authority") is a public body, duly formed under the Sewerage Authorities law, constituting Chapter 138 of the Laws of New Jersey of 1946, as amended (Chapter 14A of Title 40 of the New Jersey Statutes Annotated) and possesses the powers set forth therein; and

WHEREAS, the Authority has awarded a biennial contract for the Miscellaneous Repair to combined sewers of various configurations, lengths, sizes materials and their appurtenances; and

WHEREAS, the Authority awarded such a Miscellaneous Repair Contract as required by the New Jersey Contract laws to Cliffside Paving; and

WHEREAS, it is the recommendation of the Authority Engineer that Cliffside Paving, be directed to commence the work as detailed in the attached report prepared by OMI (February 2024 Project), identified as "Exhibit A", for an amount of money estimated at approximately \$61,875.00; and

WHEREAS, the Chief Financial Officer has certified that funding is available through the Authority's Fiscal Year 2022-2023 Operating Budget.


NOW, THEREFORE, BE IT RESOLVED that Cliffside Paving be directed to proceed with the work as herein noted.
